

Privacy Policy

Personal Information I Collect

When you interact with me, I may collect personal information, such as:

- Name

How I Collect Information

I may collect information:

- Directly from you when you provide it, including by filling out forms, setting up a personal profile, participating in promotions, or contacting us through our "Contact" form.
- Automatically as you interact with me, such as location data, times and dates of logins.
- That you share, post, or transmit when interacting with me
- From third parties, including social media platforms you use to interact with me

How I Use Information

Children Under 16

Accessing Your Personal Information
